#### Overview

The <u>U.S. Department of Justice</u> (DOJ), <u>Office of Justice Programs</u> (OJP), <u>Bureau of Justice Assistance</u> (BJA) seeks applications for funding to reduce the number of deaths and injuries of individuals with forms of dementia, such as Alzheimer's disease, or developmental disabilities, such as autism, who, due to their condition, wander from safe environments. This program furthers the DOJ's mission by providing funding to law enforcement and other public safety agencies to implement locative technologies that track missing individuals, and it provides funding to such agencies and partnering nonprofit organizations to develop or operate programs to prevent wandering, increase vulnerable individuals' safety, and facilitate rescues.

This solicitation incorporates guidance provided in the <u>OJP Grant Application Resource Guide</u> which provides additional information for applicants to prepare and submit applications to OJP for funding. # Program Description

#### Overview

OJP is committed to advancing work that promotes civil rights and racial equity, increases access to justice, supports crime victims and individuals impacted by the justice system, strengthens community safety and protects the public from crime and evolving threats, and builds trust between law enforcement and the community.

With this solicitation, BJA seeks to support local jurisdictions' efforts to reduce the number of deaths and injuries of individuals with forms of dementia, such as Alzheimer's disease, or developmental disabilities, such as autism, who, due to their condition, wander from safe environments.

#### Statutory Authority

Pub. L. No. 103-322, Sec. 240001 (codified at 34 U.S.C. 12621)

## Specific Information

Kevin and Avonte's Law, enacted in 2018, authorized BJA to support local efforts to address this public safety challenge by providing grants to health care agencies, law enforcement and other public safety agencies, and nonprofit organizations that (1) implement locative technologies to track missing individuals, and/or (2) develop or operate programs to prevent wandering, increase individuals' safety, and facilitate rescue.

Applicants should propose solutions that are the least restrictive and intrusive and directly benefit and support individuals, and families of individuals, with forms of dementia, such as Alzheimer's disease, or developmental disabilities, such as autism, who are likely to wander.

Category 1 supports health care agencies, law enforcement and other public safety agencies, and nonprofit organizations to develop comprehensive approaches designed to prevent and respond effectively to the wandering of individuals with forms of dementia, such as Alzheimer's disease, or children with developmental disabilities, such as autism.

Category 2 supports health care agencies, law enforcement, and other public safety agencies to purchase tracking technology designed to locate and recover individuals with forms of dementia, such as Alzheimer's disease, or children with developmental disabilities, such as autism, in the event they wander from safe environments.

#### Goals, Objectives, and Deliverables

#### Goals

The goal of the program is to support local jurisdictions' efforts to reduce the number of deaths and injuries of individuals with forms of dementia, such as Alzheimer's disease, or developmental disabilities, such as autism, who, due to their condition, wander from safe environments, through the implementation of proactive programs and the acquisition of locative technology.

#### Objectives

Category 1: The objective is to design, establish, or operate comprehensive, locally based.

proactive programs to locate or prevent the wandering of individuals with forms of dementia, such as Alzheimer's disease, or developmental disabilities, such as autism, who, due to their condition, wander from safe environments.

Category 2: The objective is to purchase, develop, or implement locally based tracking technology for individuals with forms of dementia, such as Alzheimer's disease, or developmental disabilities, such as autism, who, due to their condition, wander from safe environments.

#### Deliverables

#### Category 1:

- 1. Increase public awareness of missing persons with Alzheimer's disease and other forms of dementia or developmental disabilities, including what to look for, how to approach the individual, and who to call.
- Provide prevention and response information, including online training resources, and referrals to families or guardians of individuals who, due to their condition, wander from a safe environment.
- 3. Develop or expand community partnerships among local law enforcement, other public safety agencies, and the communities they serve in an effort to prevent persons with forms of dementia or developmental disabilities from wandering, and to locate them if they go missing.
- 4. Provide education and training, including online training resources, to first responders, school personnel, clinicians, and the public to:
- a. Improve safety and reduce the incidence of wandering of persons with dementia or developmental disabilities.
- b. Support the rescue and recovery of individuals who wander from safe environments.
- c. Recognize and respond appropriately to individuals who wander from safe environments.
- 5. Provide prevention and response training and emergency protocols to school administrators, school staff, and families or guardians of individuals with dementia or developmental disabilities to help reduce or prevent the risk of wandering by such individuals.
- 6. Develop, run, or improve a notification system that generates alerts, advisories, or other information for the recovery of missing individuals with dementia or developmental disabilities.

#### Category 2:

- 1. Partner with health care agencies or state or local public safety agencies in the design and use of locative technology. Applicants should include letters of support and/or memorandums of understanding (MOUs) to demonstrate the intent to partner with these agencies. Note:
- a. Any collection, use, and storing of data under this program is solely for the purpose of preventing injury or death of a person assigned a tracking device.
- b. Participation in this program is voluntary for participants. A guardian or parent shall make any decisions about whether or not to accept a tracking device for an individual under 18 years of age. Similarly, someone with the legal authority to make decisions for another adult may make the decision for that adult.
- c. Applicants should create public awareness and outreach plans for the tracking program and

practices.

d. Participate and assist in any OJP efforts to develop standards and best practices for the use of noninvasive and temporary tracking devices that a guardian or parent has determined to be the least restrictive alternative to locate individuals.

To receive this consideration, the applicant must describe how the proposed project(s) will address potential racial inequities and contribute to greater access to services and opportunities for communities that have been historically underserved, marginalized, and adversely affected by inequality, and identify how the project design and implementation will specifically incorporate the input or participation of those communities and populations disproportionately impacted by crime, violence, and the criminal justice system overall. Examples addressing this requirement include, but are not limited to, the following: budgeted project planning and/or implementation meetings with community stakeholders representing historically underserved and marginalized communities; outreach and/or public awareness campaigns specifically tailored to historically underserved and marginalized communities to encourage participation in the proposed project(s); budgeted incorporation of members representing historically underserved and marginalized communities in program evaluation, surveys, or other means of project feedback; and partnership

2. Executive Order 14074, Advancing Effective, Accountable Policing and Criminal Justice Practices to Enhance Public Trust and Public Safety requires the Attorney General, through discretionary grantmaking and training and technical assistance, to encourage and support state, tribal, local, and territorial governments and law enforcement agencies to adopt the policies, best practices, and guidelines addressed in the executive order, including, but not limited to: (i) investigating deaths in custody; (ii) recruiting and retaining diverse and service-oriented law enforcement professionals; (iii) collecting and reporting use of force and misconduct data; (iv) improving community and law enforcement dialogue; (v) responding to individuals in mental health crisis or with disabilities; (vi) the proper and responsible use of technology; (vii) restrictions on unannounced entries and certain restraints; (viii) addressing implicit bias; (ix) restricting the use of militarized equipment; (x) broader criminal justice reform; and, (xi) officer wellness and mental health.

As such guidance is developed in accordance with the executive order, and where the guidance is applicable to the specific solicitation, DOJ will identify specific opportunities for training and technical assistance and priority consideration for applications that demonstrate or seek to support the policies of the Executive Order.

For the purposes of this solicitation, OJP and the Office of Community Oriented Policing Services will provide priority consideration for the following items, for which DOJ has already issued policies, guidance, and/or best practices:

- Participation in the collection and reporting to DOJ of data on law enforcement use of force and deaths in custody:
- Participation in the collection and reporting to DOJ of data on officer suicides and officers killed and assaulted;
- 3. Restrictions on unannounced entries and neck/carotid restraints; and.
- 4. Restrictions on the possession and use of militarized equipment.

To receive this consideration, the applicant must describe how the proposed project(s) will address one or more of the identified policy areas.

This abstract should be in paragraph form without bullets or tables, written in the third person, and exclude personally identifiable information. Abstracts will be made publicly available on the OJP and USASpending.gov websites if the project is awarded. See the OJP Grant Application Resource Guide for an example of a proposal abstract.

#### **Proposal Narrative**

The Proposal Narrative should be submitted as an attachment in JustGrants. The attached document should be double-spaced, using a standard 12-point font; have no less than 1-inch margins; and should not exceed 15 numbered pages. Pages should be numbered and submitted as an attachment. If the Proposal Narrative fails to comply with these length restrictions, BJA may consider such noncompliance in peer review and in final award decision.

The Proposal Narrative must include the following sections:

#### a. Description of the Issue

Describe the specific problem in the applicant's geographic area. Include data and information that have been used to identify and assess the problem, which demonstrate that the applicant understands the nature and scope of the problem. Any statistics or references used in this section should be those gathered and documented for the applicant's specific geographic area. No national statistics or references should be used unless they specifically reference the applicant.

Identify current vulnerabilities resulting from a lack of training for law enforcement or community members in working with individuals with forms of dementia, such as Alzheimer's disease, or developmental disabilities, such as autism, who, due to their condition, wander from safe environments.

#### b. Project Design and Implementation

For Categories 1 and 2, applicants will describe how they will increase public knowledge and awareness of proactive strategies that reduce wandering and/or aid in successful recovery.

Describe how the applicant will provide the services or develop and implement the activities described under the proposed project.

Describe how the applicant will appropriately use solutions that are less restrictive and intrusive and directly benefit and support individuals, and families of individuals, with forms of dementia, such as Alzheimer's disease, or developmental disabilities, such as autism, who are likely to wander.

Detail how the applicant will achieve the deliverables listed in the "Project-specific Information" section, including describing the objectives and identifying strategies for designing and achieving each program deliverable.

Provide specific information on any materials to be developed and delivered.

Describe all partners included in the proposed activities and their roles.

Describe the implementation plan for the locative tracking technology program for individuals with forms of dementia, such as Alzheimer's disease, or children with developmental disabilities, such

as autism, who have wandered from safe environments, if funds are requested for this activity.
