Overview

The <u>U.S. Department of Justice</u> (DOJ), <u>Office of Justice Programs</u> (OJP), <u>Bureau of Justice Assistance</u> (BJA) invites applicants who received an official request from BJA to apply for funding to continue work on a specific prior grant award. This correspondence would have been sent to you with instructions to apply to this solicitation. All programs will follow guidelines detailed in the original solicitation under which funding was provided. The scope, purpose, award amount, and performance period of the new project will be substantially the same as the previous one. This program furthers the Department's mission by aiding state, local, and tribal criminal justice practitioners.

Program Description

Overview

OJP is committed to advancing work that promotes civil rights and racial equity, increases access to justice, supports crime victims and individuals impacted by the justice system, strengthens community safety and protects the public from crime and evolving threats, and builds trust between law enforcement and the community. The purpose of this solicitation is to invite organizations and entities to apply for continuation funding in support of specific BJA initiatives. This solicitation is exclusively for those who received a letter from BJA to apply. All guidelines and funding rules are the same as the original funded project.

No. 116-93, 133 Stat 2317, 2409); Consolidated Appropriations Act, 2021, (Pub. L. No. 116-260, 134 Stat 1182, 1259); and, Department of Justice Appropriations Act, 2022 (Pub. L. d. Plan for Collecting the Data Required for this Solicitation's Performance Measures

Describe the process for measuring project performance. Please refer back to the applicant invitation letter or original solicitation for specific guidance. Identify who will collect the data; who is responsible for performance measurements; and how the information will be used to guide and evaluate the project's impact. Describe the process to accurately report data.
