# FY 2024 COLLABORATIVE CRISIS RESPONSE AND INTERVENTION TRAINING PROGRAM



#### Who May Apply:

State, city, township, county, or other units of local governments, public housing authorities or Indian housing authorities with public safety/peace officers/campus police, Native American tribal organizations (other than federally recognized tribal governments), Native American tribal organizations (federally recognized), and other Public and state-controlled institutions of higher education with on-campus police departments, public or state-controlled hospitals with on-campus police departments

#### Why Apply:

Receive funding to implement crisis response and intervention training (CRIT) to support law enforcement, correctional, probation and parole, and sheriff's department officers to effectively partner with mental health, substance use disorder, and community service agencies to improve responses to individuals in crisis who have behavioral health conditions or intellectual, developmental, or physical disabilities.

#### Maximum per Award:

Up to \$250,000 per award

### BJA encourages the following entities to apply:

- Agencies that have not previously received BJA funding.
- Convening or governing bodies that can apply on behalf of one or more entities.

#### Examples of strategies/ activities that can be funded:

- Create, design, and implement a new or enhanced training program in line with BJA's CRIT Curriculum.
- Analyze existing training and deployment policies and practices in collaboration with local stakeholders and agency staff.
- Adopt and implement new technology to track training implementation.

- Plan and implement other bestpractice response and training models.
- Define and track process measures as well as short- and long-term program outcomes.
- Implement a jail-based CIT curriculum.

#### How to apply and when:

Submit a two-step application.

- (1) Register in <u>Grants.gov</u> and follow the prompts to submit two forms May 15, 2024.
- (2) Then complete the full application in <u>JustGrants.usdoj.gov</u> by May 22, 2024. The application's major elements are:
  - (a) The **proposal abstract** that summarizes the problem you wish to address with your project (no more than 400 words).
  - (b) The **proposal narrative** that describes your project's strategies, activities, and major deliverables as well as your capacity to address the problem.
  - (c) The **web-based budget** form that details how you will allocate the grant funds by task, date, and responsible person.
