## BJA'S FY 2024 RESIDENTIAL SUBSTANCE ABUSE TREATMENT FOR STATE PRISONERS PROGRAM



Who May Apply:	State governments
Why Apply:	Receive formula funding to assist states with developing and implementing residential substance use disorder (SUD) treatment programs for people with substance use or co-occurring substance use and mental health disorders during detention or incarceration, as well as during the reentry process.
Maximum per Award:	Up to \$4,395,000
BJA encourages the following entities to apply:	<ul> <li>Only states are eligible to apply and must designate a single State Administering Agency (SAA) with the authority to apply on their behalf. States typically rely on a single entity within the state (e.g., SAA, Department of Corrections, Department of Public Safety, Governor's Office) to oversee the RSAT for State Prisoners Program and its subgrantees. Applicants are required to allocate at least 10 percent of the total award to local correctional facilities—provided such facilities exist—and a 25 percent non-federal match is required.</li> </ul>
Examples of strategies/ activities that can be funded:	<ul> <li>Initiate or continue evidence-based SUD or co-occurring substance use and mental health disorder treatment programs in prisons and jails.</li> <li>Increase the number of prisons and jails offering medication-assisted treatment to incarcerated individuals.</li> <li>Prepare individuals for reintegration into communities, including supporting continuity of treatment for opioid use disorder.</li> <li>Assist individuals and communities through the reentry process by delivering community-based treatment, recovery, and other broad-based aftercare services.</li> <li>Create or enhance jail-based pretrial treatment programs that use evidence-based treatment, including medication-assisted treatment.</li> </ul>

## How to apply and when:

Submit a two-step application.

- (1) Register in <u>Grants.gov</u> and follow the prompts to submit two forms by July 12, 2024.
- (2) Then complete the full application in <u>JustGrants.usdoj.gov</u> by July 17, 2024. The application's major elements are:
  - (a) The **proposal abstract** that summarizes the problem you wish to address with your project (no more than 400 words).
  - (b) The **proposal narrative** that describes your project's strategies, activities, and major deliverables as well as your capacity to address the problem.
  - (c) The **web-based budget** form that details how you will allocate the grant funds by task, date, and responsible person.
