What Is the Office of Justice Programs (OJP)?

- Project period ends July 31, 2024
- State recipients must support units of local government within their jurisdiction to reach <u>fullest complement</u> of confinement facilities in the state.
 - 'Confinement facilities' includes adult prisons and jails, juvenile confinement facilities, police lock-up, and community confinement facilities.
- For testing programs, and a lot more...
